OPTION FOR REVISING OF PREFERENCES OF ACADEMIC PROGRAMS BY CANDIDATES

2nd round of counselling for Admissions-2022 has been completed. Candidates are now given option of revising their preferences for Academic Programs prior to Round 3 of counselling. The portal for **revision of preference will be opened from 24.6.2022 to 26.6.2022 up to 10:00 PM**. The candidates may revise their preferences. Candidates are advised to fill maximum possible preferences to optimize chances of allotment. Revised seat matrix showing details of vacant seats will be displayed on the NIFT website as well as admission portal on 24th June, 2022 up to 05:00 PM.

It is NOT mandatory for candidates to revise preferences. If no change is made the original preferences submitted by the candidate will be utilised for seat allocation in subsequent rounds.

WHO CAN REVISE THEIR PREFERENCE

- Candidates who have paid the fees and opted for slide during 1st or 2nd round of counselling.
- Candidates who have paid the fees and opted for upgrade option during 1st or 2nd round of counselling.
- Candidates who have not been allotted a seat in previous rounds.

WHO ARE NOT ALLOWED TO REVISE THEIR PREFERENCES

- Candidates who have been allotted a seat as per their preference, paid the fees and have exercised the option to freeze the allotment.
- Candidates who have not registered for counselling and not uploaded the required documents during the registration for counselling.
- Candidates who have been rejected during the process of document verification.
- Candidates who have been allotted a seat in 1st or 2nd round but not paid the fees.
- Candidates who have applied for admission to NIFT through special quota/modes of entry:-
 - i) NLEA
 - ii) Artisan
 - iii) NRI candidates
 - iv) PwD candidates



INSTRUCTION FOR CAMPUS & COURSE PREFERENCE SELECTION

1. Candidates to login using their Registered User ID & Password on the Admission Counselling portal. (<http://niftadmission.in/>)
2. After logging in, click on "Course & Campus Preference" icon available on the candidates dashboard.
3. Select Course & Campus Combination from the drop down list & Click on Add button to Add the Course & Campus Preference.
4. Order of your preference will be displayed in the Selected Preferences Box.
5. Candidate can change the order of the preferences given in the Selected Preferences Box by 'Drag and Drop' the selected preference. The selected preferences can be re-ordered as per choice dragging up/down to bring it to the required position.
6. Click on "Save Button" to confirm your selection of Course & Campus preference.
7. Please fill maximum choices so that the probability of Campus allotment is optimized. There is no limit on the number of choices for Course & Campus preference that a candidate can select.
8. Once Course Preference is added it can be re-ordered but not be deleted. Least wanted preferences should be kept at the bottom of the list.
9. Before clicking on "lock choices" button you can add and re-order your choices as per your interest. Once you are sure of all your choices and the order of preference, click on the lock button to lock selection.
10. Once you click on "lock choices" button for the choice filling, **you cannot change or re-order your preferences.**
11. After successful locking of choice filling, Candidates can print the Campus & Course Preference for their reference.
12. 3rd round and subsequent rounds of seat allotment will be based on CMR & preferences chosen by the Candidates.
13. This is the final chance to modify the choice of academic program and the order of preference. All subsequent rounds of seat allocation will take place based on this selection. No repeat No further option for revision will be available to the candidates.
